Carlisle Christmas parade marshal

Dorothy Spencer overcame difficult times

By ANNA BROWN CARLISLE - You wouldn't know Dorothy Kelly Spencer is 90 years old unless she told you.

Whether she is talking about being chosen as the Carlisle Christmas Parade marshal or telling you about the hard times she faced growing up, her smooth, beautiful face glows with joy and happi-

"I was happy," she said about leading the parade on Dec. 9. "I was very, very, happy. At my age, it is a blessing."

Dorothy is a lifelong resident of Carlisle and the widow of Mike Spencer Sr. She said God and her good husband are the reasons she survived and thrived during difficult times. When Mike passed away on June 23, 2014, they had been married 67 years.

Dorothy is retired after working 17 years in the Monarch Elementary School cafeteria.

When Dorothy was 14 her mother, Leola Jeter Kelly, passed away, leaving Dorothy and her three



younger brothers. "My baby brother (William Ray "Pete" Kelly) was nine months old. I raised him from a baby in my arms."

Dorothy remembers the day her mother passed

"She had been ailing and that night she got real sick and my daddy had my uncle to take her to the hospital," she said. "He carried her to Whitmire but they sent her on to Newberry. I heard her tell my Daddy and I didn't know what she meant, 'Don't separate my children.' I wasn't thinking about that she wasn't coming back, but that is what she meant."

Later her father came in and said, "Mama won't be coming home."

"That was the worst time of my life," she said. "My Mama was gone and here I was with three brothers under me that I had to raise. But praise God, he gave me strength. We were loving and kind

to each other." Dorothy remembers walking five miles to Jeter Chapel Church and to Oak Grove School.

"At that time didn't many people have cars," she said. "When we would come from church the road was full of people walking."

Robbery **suspect** gets **12 years**

A Union man who was accused of robbing a WBCU employee was sentenced to 12 years in prison last week.

Tracey Leon Bishop, 36, of 413 South Church St.,

pleaded guilty on Dec. 13 to strongarmed robbery. Judge Dan Hall g a v e Bishop credit for 287




days he has served in the Union County Jail.

Bishop was arrested on March 6, 2017, by the Union Public Safety Department. He was charged with strong-armed robbery and indecent exposure. Lt. Kevin Powers said the WBCU employee who was robbed on Jan. 14, 2017, picked Bishop out of a photo lineup.

Bishop also was accused of taking money from a at Fairforest Apartments on April 23, 2016, and with robbing a 69-year-old man on West South Street on Feb. 25, 2017. The victim in the February case has died, causing that charge to be dropped. The other charge was dropped as part of Bishop's plea agreement.

At WBCU Radio, the employee was at work around 5:50 a.m. when a man banged on the door. The employee opened the door and the man asked if he could borrow \$5 to help fix his broken down car. The employee gave him the money. A short time later the man returned and wanted more money. The employee told the man he had no more money and the station was closed. Chief Sam White said the man put his hand in his pants,
